

# Proposed Witchcraft Convictions (Pardons) (Scotland) Bill

## Introduction

A proposal for a Bill to pardon all those convicted under the Witchcraft Act 1563.

The consultation runs from 23 June 2022 to 15 September 2022

It will help to highlight how women can be persecuted simply for being women ie on the basis of their sex (although I appreciate it applies to a few men too, it was mainly women) and show that Scotland will no longer tolerate such persecution. It would send a strong message in line with the Equality Act 2010 that females are valued in Scottish society and take responsibility for a time when that wasn't the case. It may also serve as a lesson for now and future generations at how easily women who are considered problematic by a misogynistic society can be persecuted and the extremes to where that can lead.
