

Proposed Witchcraft Convictions (Pardons) (Scotland) Bill

Introduction

A proposal for a Bill to pardon all those convicted under the Witchcraft Act 1563.

The consultation runs from 23 June 2022 to 15 September 2022

I fully support the need to address the darker parts of our history and to formally legislate that those accused of witchcraft were not criminals.

Q1. Which of the following best expresses your view of the proposed Bill? (Please note that this question is compulsory.)

I think the bill covers many topics well. I do think it misses an acknowledgement to the link between 'witchcraft' and paganism. And the dangers of demonising a spiritual belief different to that of the main stream. And that, though they may not have claimed the term at the time, some of the women accused may well have been witches as we now understand witches as a part of paganism. And the crime as much being of making 'witchcraft' a crime, as it being falsely accusing folk of it. There are obviously nuances in how the word witch is used in the different time periods, but I think the absence of an acknowledgement of the non-criminality of paganism which may be related to 'witchcraft' of that age, would enhance the bill.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

I think legislation is required to historically document the pardoning and implicit apology to those falsely accused of a falsely criminalised act.
Culturally, in the present, I think a memorial and continued conversation may prove more effective at making the changes in attitudes discussed in the bill. But for future generations to have legal, formalised documentation of the nations pardoning of this criminalisation, I think the legislation is needed.
