Proposed Witchcraft Convictions (Pardons) (Scotland) Bill

Introduction

A proposal for a Bill to pardon all those convicted under the Witchcraft Act 1563.

The consultation runs from 23 June 2022 to 15 September 2022

These people were convicted for something which we now know could not have been true. A pardon for them sends a powerful message about the maturity of a state to accept and own that it made mistakes in the past, and also, more importantly, it means that these women (mostly) and men are pardoned of these

crimes with which they never should have been charged. It also sends a message to those parts of the world where witchcraft is still used mainly against old women and young girls, that this is not acceptable.

I believe that because it would not be feasible to trace descendants of those so accused, that a legislated pardon is required. While technically it would pardon those accused, the most powerful aspect of such a legislated pardon would be the Scottish state confronting and rectifying its own errors.

I cannot see any legitimate claim against the state as a result of this pardon. There is no need to establish a part of government to receive or process applications for pardon. This is a cost free, but important piece of legislation.

I am a cis-gendered middle aged white man. It is important to state that at the outset. The accusation of witchcraft in Scotland historically, and in many jurisdictions presently is used to predominantly persecute women and girls. And it is a power predominantly exercised by men. Beyond witchcraft, women are disproportionately targeted. This weekend we only have to look at the furore around the Finnish PM enjoying a night with her friends to see what happens when a woman seeks to have a voice. Owning historical wrongs - in this case against (largely) women - is a way for states to draw attention to what still needs to be done. I only see this bill having a positive impact.
