

Proposed Witchcraft Convictions (Pardons) (Scotland) Bill

Introduction

A proposal for a Bill to pardon all those convicted under the Witchcraft Act 1563.

The consultation runs from 23 June 2022 to 15 September 2022

I cannot offer opinion as to best procedure legally, not my field. I would consider total exoneration of any charges the only way to clear those often maliciously and falsely charged under a regime created under religious extremism, intolerance, and political authoritarianism. A pardon implies a crime committed. Formal total exoneration, in whatever form is legally recognised, apology, and removal of any laws that relate to the medieval obsession with any religion.

We are considering persons put to death, largely, for not fitting the norm of the day, as decreed by Royal and parliamentary edict, denounced, tried, convicted on spurious evidence, because logically there was none.

General

While there are formal religions now to identify that which had "Witchcraft" as an identifier(eg Wicca), the more formal Pagan acceptance is also valid. Modern sectarianism and other religious intolerance is still exhibited frequently, though in some ways lesser than would have been relatively recently. Paganism, Wicca, is still greatly misunderstood, however, especially by those more indoctrinated in the formal religions of the last two millennia. But understanding of these much older, founded in respect for land, environment, creation, all life, have a modern role to play in this time of environmental crisis. Understanding and acceptance of that will benefit all.
