Proposed Witchcraft Convictions (Pardons) (Scotland) Bill

Introduction

A proposal for a Bill to pardon all those convicted under the Witchcraft Act 1563.

The consultation runs from 23 June 2022 to 15 September 2022

Please explain the reasons for your response.

On its own, a pardon for all those convicted of witchcraft is an important righting of wrongs done to people living in Scotland in those times, and follows on from Ms Sturgeon's apology. It also puts to rest any doubt that witchcraft is anything remotely resembling a crime, and that persecution of individuals on that basis is unacceptable anywhere in the world today.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

Legislation is an unequivocal removal of the convictions and guilt of those convicted, and makes the statement of intent of the Scottish Government clear that witchcraft is not a crime and that those accused of it should not be persecuted, today or ever.

I'm not qualified to answer this one, but other than adding to historical records including recording legislation and the process in parliament, I do not anticipate that there are many costs associated with this particular bill. Posthumous pardons are unlikely to lead to much activity other than these.
